1. On April 21, 2016 at approximately 2200 hours this officer along with Everett Police Detective Robert Hall conducted an interview of [REDACTED] at her residence of [REDACTED] in Everett. [REDACTED] stated that earlier that same afternoon she was sitting on her front porch and that a Hispanic male walked by her house. The male seemed to be intoxicated as he walked by her house and he pointed at her when he saw her. [REDACTED] was alarmed by this but did not call the police. The male spoke to her but she could not understand what he was saying.

2. The male walked around in the area of the front of her house and she observed him break a whiskey bottle or what appeared to be some type of glass alcoholic container on the street in front of her house. The male then walked down the hill towards Everett Square.

3. While speaking to [REDACTED] I showed her a photograph of Mario Mejia Martinez (DOB 1/29/1968) which had been provided to me from his brother [REDACTED] (DOB [REDACTED] 1978) [REDACTED] confirmed that the person she saw break the bottle in front of her house was the man in the photograph.

4. [REDACTED] had no further information and the interview concluded.
