SUBJECT: INTERVIEW OF OFFICER JAMES MACGREGOR, EVERETT POLICE
DEPARTMENT

1. On 04-23-16, this officer interviewed Officer James MacGregor of the Everett Police Department at the Everett Police Detective Office; also present was Sgt Scott Stalbaum of the Everett Police
2. Officer MacGregor was working the evening shift on 04-21-16, when Mario Mejia Martinez was fatally shot by Officer Joseph Pepicelli at the intersection of Broadway/Chelsea/Norwood Streets in Everett.
3. Officer MacGregor was not present when fatal encounter occurred but was responding as a backup officer traveling on Chelsea Street westbound towards Broadway. Officer MacGregor stated he heard over the radio Officer Pepicelli saying "Drop the knife" as he was responding.
4. Upon arrival Officer MacGregor observed the suspect was down in the intersection and bleeding, he was also still armed with a knife in his right hand. Officer MacGregor stated he asked other officers to cover him, he "gloved up", approached and disarmed the subject of a large folding knife, and then tossed the knife a safe distance away, officers then applied emergency first aid to the suspect.

5 Officer MacGregor's statement was recording, and should be referred to for exact details of his statement. Officer MacGregor also provided a diagram referred to on the statement.

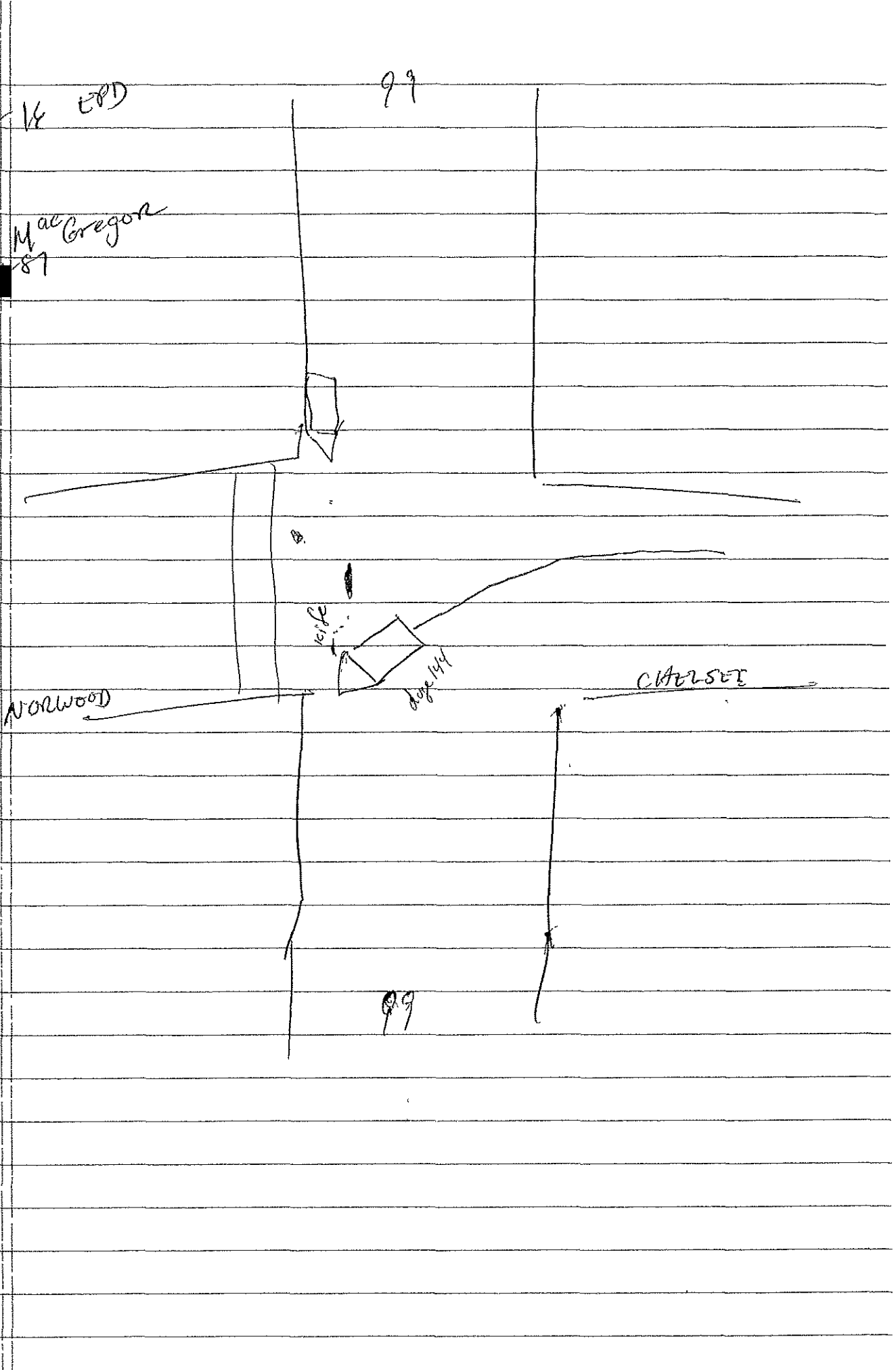
